Aims

The aim of this workstream group is to facilitate a sector wide approach to the delivery of high quality and equitable acute stroke and TIA services; to identify future service development needs and make recommendations to facilitate the continuous improvement of these services across the sector.

Objectives

The objectives of the workstream group are to:

- Identify and address delivery issues for acute stroke services across SWL including repatriation, mimics, capacity etc.
- Monitor HASU, SU & TIA service performance against the London Stroke Strategy standards
- Identify and log risks, highlight any issues and ensure actions are taken to mitigate risks and manage issues
- Identify need for specific, time limited, action focussed task groups as required e.g. SU nursing competencies development group
- Evaluate and monitor the progress on the work of the task groups at agreed regular intervals and ensure delivery against agreed actions
- Facilitate involvement / representation of all relevant professionals, organisations and agencies
- Ensure patients and carers views are incorporated into the workstream task groups and the work plans
- Identify and address training and education needs to improve consistency across sector professional groups and MDTs
- Facilitate communication and information sharing within and between organisations
- Understand current provision of end of life care and potential areas for improvement, share good practice, including processes to support patient choice
- Review performance against London standard RI5 (NICE Quality Standard 7) – % patients receiving 5 x 45 minute face-to-face sessions per week of each therapy as necessary
